Courses Taught (Undergraduate Level)

1- Community Health Nursing/Theory

This course is designed to help the students acquire a broad perspective of community health nursing (CHN) by applying different concepts of community health nursing with emphasis on health promotion and primary health care

2- Community Health Nursing Clinical

This course focuses on introducing the student to the group and population-based nursing practice by reinforcing the primary health care activities, and the course prepares the student with basic knowledge & skills required to provide promotive, preventive, curative, and rehabilitative care to specific population groups and communities who are well, ill, or at risk in various community setting

3- Fundamentals of Nursing

This course is considered as an introductory course for other nursing courses. The course content includes main concepts related to nursing as a profession, including theories of wellness and illness, and often physiological, psychological, emotional, and social concepts necessary to deliver holistic nursing care through the utilization of the nursing process.

4- Therapeutic Communication and Health Education

This course aims to introduce students to the theories and techniques of health education, social marketing, learning/ teaching process, and behavioural change to individuals, families, and community through proper therapeutic communication.

5- Physical Examination

This course aims to provide students with the knowledge and skills required to assess their health status during health and illness throughout their life cycle.

6- Mental Health Nursing

This is an introductory course in mental health nursing. Human beings are viewed from a holistic perspective: including the biological, environmental, cultural, and interpersonal factors that foster mental health.

7- Gerontological Nursing

Gerontological Nursing provides an opportunity to explore the area of gerontological nursing, a field of nursing that focuses on the care of older adults. The course presents older adults' unique health care needs and introduces students to nursing approaches to managing those needs.

Courses Taught (Graduate Level)

1- Advanced Community Health Nursing/ Theory

This course will provide the students with an opportunity to develop specific nursing skills and competencies related to assessment, monitoring, and diagnoses of the health status of individuals, families, aggregates, and communities

2- Advanced Community Health Nursing/ clinical

In this course, students will work in teams to prepare community needs assessment elements for a selected community in Jordan. They will learn to use secondary data (e.g., census and other administrative data) to examine your chosen community's health status.

3- Advanced Research Methods in Nursing

This course aims to provide students a comprehensive knowledge of advanced research methods in nursing. This course focuses on research critique, critical appraisal approach in discussing research findings, and research utilization into clinical practice.

4-Health policy

This course focuses on local health policies that affect the health of the population in Jordan. The course provides an overview of the policymaking process in general and nursing and healthcare policy development within the health care system.

5- Palliative Care

This course provides students accurate and comprehensive knowledge of pain management and symptom management among critically ill patients and their families
